In order to keep a solid workflow, fees for vendor booths will not be processed the same day of your set up. Payment for the booths will be required with the application. Spaces are limited to 40 with only 10 double booth spaces available so please send your information in with the fee as soon as possible. **FYI we sold out of booth spaces by May1 last year.** Priority will be given to booths that will be set up booth days. I know that it is an election year but political booths will be limited to have space for our craft and food vendors.

Spaces are a 12' X 12' area and the application fee is \$5.00 each. If a second space is required the cost will be an additional \$15.00. (No more than two spaces will be reserved).

Exhibitors may set up their own tents on Thursday, anytime after 5:00 pm.

Exhibitors must supply their own tents, tables, chairs, electrical cords and trash receptacles/waste baskets.

Exhibitors are responsible for cleaning their respective spaces after the show.
